

The Primed online knowledge system contains all the polices, templates and documents you need to manage your business and maintain compliance.


After logging in for the first time, it may prompt you to create a user profile. This is not mandatory and you can simply close or skip this step. You can always update this at a later time, if you wish.

Employment & HR is broken down into 9 key areas:



Information Security




The Information Security area provides you with the documents and tools to maintain compliance and reduce the risk of threats.


