# What do you do at Outset and how do you support our clients?

I am a senior corporate lawyer leading on transactions as well as advising clients on day to day issues that affect their business. I really enjoy spending time getting to know my clients and understanding what makes them tick. Above all else, I aim to spot what the client needs rather than what they may want, sometimes these are quite different things and it's not always easy to see when you are at the epicentre of the situation.

### Give us a brief timeline of your career so far

I qualified some time ago now and I have spent a number of years (perhaps more than I care to mention here) working in busy corporate and commercial teams. Following qualification I spent 5 years working with a team in London during which I experienced two mergers. I then spent some time working in Kent, went through a third merger and then gradually moved West to join the team at Osborne Clarke LLP in Reading and then ultimately lead a team in Dorset before joining Outset. I have been lucky enough, partly due to the mergers but also down to my slightly nomadic nature, to spend time in some very different firms and teams. This has given me the benefit of exposure to some fantastically varied work and clients but also first-hand experience of the varying ways in which businesses are run and insight into team dynamics.



# What has been your biggest challenge in your role?

The biggest challenge has been the move to entirely remote working during periods of lockdown. Whilst we were well adapted to remote working as a business and I generally work from home the majority of the time to go to an entirely remote way of working for prolonged periods has presented interesting challenges for individuals and the business as a whole. Whilst there are efficiencies to be gained because travel time is non-existent and meetings are so easily conducted via video calls, it naturally makes certain things more difficult. I think we have risen to the challenge but I am looking forward to being in the office with the team more regularly.

I love that every day is different. I am a natural problem solver and enjoy lateral thinking. To have a job where I am asked to come up with solutions on an almost daily basis is great! It's a cliché but I genuinely do enjoy helping clients achieve their aims.
